\*On an exceptional basis, the participants attending the train-the-trainers' session in the **Module on Didactics** will be reimbursed under Category A as upon completion of the training, the participants will be automatically added to the EASO Expert and Trainer's Pool and might be requested to deliver didactic session within train-the-trainers' sessions organised by EASO.
