## EX ANTE PUBLICITY

**SUBJECT: Negotiated Procedure for the Provision of Carpentry and Joinery Works for EASO  
EASO/2017/554**

### I. Description of the services

The European Asylum Support Office (EASO) is planning to procure services and supplies related to Carpentry and Joinery Works including kitchenette units, repair and other ancillary works envisaged for the next 4 years at three office Blocks, A, B and C situated at Winemakers Wharf, Valletta Harbour, MRS1917.

More in detail, the requested services shall mainly include:

- Preventive maintenance, repair and replacement of parts if necessary of all joinery and carpentry works on all levels of Blocks A, B and C, including corridors and common areas.
- Parts required for the repair, maintenance and upkeep of the above may include: door closer, door stopper, door handle, security cylinder lock, mechanical door lock, door hinges, cupboard lock, etc.
- Supply and install kitchen Base Cabinets and kitchen Wall Cabinets of different sizes.

### II. Description of the contract

EASO envisages awarding a framework contract. The duration of the contract will be 4 years. The estimated maximum amount for this contract is € 110,050.000.

### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators through which EASO may award the above-mentioned contract.<sup>1</sup>

This publication has an indicative value and constitutes no obligation to award a contract for EASO nor to invite to tender for middle value contracts procedures any economic operator having expressed its interest in participating.

Only the tenderers invited by the contracting authority to participate in a procedure for awarding middle value contracts will be admissible.
